Councilman Hutchinson moved to approve the consent agenda and the minutes from the previous meeting. Councilman Henry seconded. Motion passed 3-0.

The Mayor opened up the public hearing assessments on Sixth and Willow SBD.

Bond Counsel Tyler Ellsworth updated Council on the assessments and provided information.

Councilman Hutchinson moved to close the public hearing. Councilman Henry seconded. Motion passed 3-0.

Councilman Henry moved to approve Ordinance 936 levying and assessing special assessments on certain lots for special assessments on internal improvements. Councilman Hutchinson seconded. Motion passed 3-0.

Resolution 01-0108-2025 setting February 12 bond sale was brought before council for discussion.

Councilman Hutchinson moved to approve the Resolution 01-0108-2025. Councilwoman Pruitt seconded. Motion passed 3-0.

Resolution 02-0108-2025 was brought before council to annex and under the authority of KSA 12-520 on I-35 adjoining the Southernmost boundary of the City of Wellsville, including the on and off ramps from the interstate onto K-33.

Councilman Henry moved to approve Resolution 02-0108-2025. Councilman Hutchinson seconded. Motion passed 3-0.

The CMB license for TA Express was brought before council. Councilman Hutchinson moved to approve the CMB license. Councilwoman Pruitt seconded. Motion passed 3-0.

City Superintendent Darien Kerr gave the Public Works activity report. Council asked if Public Works could move the snow away from the hydrants for safety concerns.

Chief Hackler gave the Police activity report. He reported no major accidents over the snow storm. Chief said one officer hit a raccoon and the raccoon hit the radiator, the vehicle will need repaired. Chief said in the budget we had approved the speed-message trailer and they will be increasing prices in February, he asked permission to purchase that now before prices raise.

Councilman Hutchinson moved to approve the purchase of the message sign. Councilman Henry seconded. Motion passed 3-0.

Councilwoman Nichole Pruitt made a motion to recess into executive session at 6:30 p.m. to discuss attorney client privilege and economic development pursuant to KSA 75-4319(b)(2). The open meeting will resume in the City Council chambers at 6:45 p.m. Tyler Ellsworth our bond council, Pat Burton, Isaac Mallory and Tammy Jones was asked to stay.
